2010 Terms & Conditions

Uniform.....

All enrolled dancers are required to wear their specific class/style uniform and shoes to class. Hair must be tied neatly off the face. No jewellery to be worn to class for safety reasons.

Enrolment.....

Each dancer enrolling at Vision must complete an enrolment form and pay the \$30 fee. This fee covers insurance, license and administration costs. Each dancer will receive their studio t-shirt once this fee is paid. This fee must be paid at the time of enrollment.

Class Payments.....

At Vision we have a pay-as-you-go system. Students are to present their tickets or payment at the start of each class. Dancers will not be able to attend class if the fee has not been paid. There are no refunds for lost or stolen dance tickets. Please refer to the enrolment brochure for class fees.

Public Holidays.....

Vision does not hold classes on any public holidays. The newsletter will inform you of these dates. Newsletters are handed out to students and emailed to the family three times a term. It is your responsibility to read all notes and keep informed of the events at Vision.

Watching Classes.....

You are welcome to watch classes at Vision, but we do ask that you remain quiet during the class, turn OFF your mobile phone, no food in the waiting area and please do not disturb the teacher or the dancers during the class.

Personal Property.....

All property should be stored in the spaces provided in the dressing room area. Lockers are available if the dancers wish to keep their items at the studio. All lost property not collected at the end of each term will be donated to charity.

Video & Photography.....

Please do not take photos or video during class without the teacher's permission. By signing this form you permit Vision to use your child/s image for promotional purposes.

Dance Team & Vision Vipers.....

All students enrolled in Vision Dance Team or Vision Vipers (Black Squad) must enroll for the entire 12 months and sign a performance agreement. 100% commitment is required and must be the dancer's number one after school activity. Acceptance is via invitation and audition only.

Important Information.....

* Dancers must be on time for class and have payment ready for collection

* Dancers are to be picked up on time at the end of their class. When dancers leave the studio they are out of our care.

* Parents are responsible for maintaining up to date contact and medical details.

* Vision has a first aid kit onsite however, in the event of a medical emergency, a dancer's parent or guardian will be contacted for the child to be picked up or permission asked to take the child to the nearest medical centre. In the event of a serious emergency and ambulance will be called. This is all covered in the personal medical cover insurance policy.

* Dancers must wear the appropriate dance uniform to class, hair must be kept off their face and the correct footwear must be worn for every class. No jewellery is to be worn.
